The Netherlands Business Council - Privacy Policy

Overview

The Netherlands Business Council UAE (“NBC”) Privacy Policy (“Policy”) sets out the details of how the NBC uses and protects the information that you provide to us. Please read the below carefully. By visiting www.nlbusinesscounciluae.com or sharing your information with the NBC, you are consenting to the practices outlined in this Policy.

Please note that this Policy may be modified or supplemented at any time by the NBC, in particular to comply with any legal, regulatory, jurisprudential or technological developments. This Policy will be posted on the website, with the date of the latest update posted at the bottom of the Policy. It is suggested that you regularly consult this Policy to become aware of any changes.

Uses of Personal Information

By providing your Personal Information, you expressly agree that it will be processed and used by NBC to offer members the full benefits of membership and fulfill its mandate.

In order to process the NBC membership the NBC requires for certain personal information such as your name, email address, telephone number, company and function, passport, trade license or other documents (“Personal Information”). Other NBC services and supports such as events, Loyalty program and Flexpool also require certain personal information. We respect your privacy and protect the data that we collect and process about people who visit our website as well as our members, business contacts, partners and employees.

As a general principle, your decision to provide Personal Information is entirely voluntary; and there are no detrimental effects for you if you choose not to consent or provide personal data. However, there are circumstances in which NBC cannot act without receiving certain personal data, such as processing membership, registration for events or sending updates and offers. In these cases, NBC will unfortunately be unable to provide you with these services without the relevant information.

Personal Information.

If you provide Personal Information to the NBC about someone else (such as one of your company's directors or employees or someone else with whom you have business dealings), the NBC will assume that you have taken the necessary steps to ensure that you are entitled to disclose that personal information to the NBC and that, without taking any further steps, we may collect, use and disclose that Personal Information as described in this Privacy Policy.

The NBC may take pictures of you as an attendee or speaker at a seminar or other event, and publish these pictures on the NBC website, mailers, newsletters or social media. Should you not wish to have your picture posted, please send an email to office@nlbcuae.com

If the NBC would like to use Personal Information for anything other than providing NBC membership or services and supports, such uses will only be performed when your prior permission has been requested and you have consented to these uses.

Only the NBC is the recipient of your Personal Information. This information, whether in individual or aggregated form, is not transmitted to third parties, other than in the course of our liaison role with the Embassy /Consulate General of the Kingdom of the Netherlands to the UAE in Dubai or to the third party service providers and subcontractors with which the NBC works or as required by law. Neither the NBC, nor any of its subcontractors, sell the Personal Information of members and users of this website.

Uses of Personal Information

The NBC may share your Personal Information with any other NBC member or when required for obtaining event permits or registrations or other approvals with relevant authorities. The NBC may also have a duty to disclose or share your Personal Information in order to comply with any legal obligation, or to protect the rights, property, or safety of the NBC, our members, business partners or others. This includes exchanging information with governmental authorities or, potentially, other companies and organisations for the purposes of fraud protection and credit risk reduction.

Rights of Access, Communication and Rectification

We may use the information we collect from you when you register, make a purchase, sign up for our newsletter, respond to a survey or marketing communication, surf the website, or use certain other site features. You have the right to view your Personal Information and request a copy of their Personal Information. In addition, you may ask the NBC opt out of receiving electronic communications from the NBC. In addition, you are also able to request the rectification, updating, locking or deletion of data concerning you that may be inaccurate, erroneous, incomplete or obsolete. The NBC agrees to respond to your request for access, rectification or opposition or any other request for additional information within a reasonable period of time from receipt of your request.

Do we use cookies?

We do not use cookies for tracking purposes. You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies. You do this through your browser (like Internet Explorer) settings. Each browser is a little different, so look at your browser's Help menu to learn the correct way to modify your cookies.

If you disable cookies off, some features will be disabled that make your site experience more efficient and some of our services will not function properly.

Security

All Personal Data provided to us is secured on our website via our service providers who may be located outside of the UAE. By submitting your Personal Information, you agree to this transfer, storing or processing. We will take reasonable steps to ensure that Personal Information is treated securely and in accordance with this Privacy Policy. (Our website is scanned on a regular basis for security holes and known vulnerabilities in order to make your visit to our site as safe as possible.)
